

## Well-Read Dragons Book Group

Too hot for you? You may want to stay in and read *Tryweryn: A New Dawn? The Legacy of the Drowning of Capel Celyn*, by Dr. Wyn Thomas, which will be discussed on **August 3**, 2024. Mary Morris Mergenthal will lead the discussion! Well-Read Dragons meets from **11:30 am – 1:00 pm**, and the Zoom link is provided to your left.

Based on over 20 years of research, *Tryweryn* has been described as a definitive account of the controversial flooding of *Cwm Tryweryn* (Tryweryn Valley) in North

Wales in the 1960s to increase the city's water supply. Dr. Thomas lays out the constitutional journey of the Tryweryn Reservoir Bill; the impact that the construction of the *Llyn Celyn* reservoir had on those directly affected; the political advances that the Welsh nation subsequently experienced, and the outpouring of Welsh cultural expression which also



resulted from Cwm Tryweryn's contentious drowning.

Were the decisions made designed to stymie the growth of political Welsh nationalism and to send a message that Wales "rightfully" belonged in the family of British nations? Whatever the truth may be, the flooding of *Cwm Tryweryn* is said to have begun the process of devolution and in no small measure to have led to the creation of Welsh Assembly. As with all books this group reads, the account comes highly recommended: Gwenno Robinson, of <u>The Welsh Agenda</u>, reports that "Thomas is thorough and comprehensive in his approach throughout the book, seeking to understand the why and the how.," and our beloved Lord Dafydd Wigley states, "This detailed study casts new light on a hugely significant political event which was arguably, a turning point in Welsh history." And to **all our members** who contribute when and how they can. (Please forgive me if I've forgotten someone.) It does take a village!

**Second**, because no one came forward until the last minute to fill the open space on our board created by Ryan Ander-Evans, who is leaving the board this year, a change to Society Bylaws was deemed necessary to ensure that the Society is not required to have seven board members in the event that seven individuals are not available to serve. The law governing non-profits in the State of Minnesota requires a minimum of three board members overall, so we are asking members to approve a change to the Bylaws to officially reduce the number we require to three. We will strive to have at least five members on the board, but with our aging membership and four board members ending their term next year, the board thought it best to make this change for the long-term. We also propose changes that authorize alternate meeting and voting methods.

Board service doesn't take a lot of time – we hold about four meetings a year on Zoom – and it's a great chance get to know other board members and exercise your creativity in planning events!

Please review the proposed changes to the Bylaws. You can vote at the annual meeting or, if you are not able to join us, feel free to send an "I approve the Bylaws, as amended" or "I do not approve the Bylaws, as amended" to the Society President by e-mail or snail mail. Mail-In votes will be counted after the Annual Meeting. Unreturned ballots will be counted as votes approving Bylaws, as amended.

# AMENDED AND RESTATED BYLAWS OF THE SAINT DAVID'S SOCIETY OF MINNESOTA, INC.

This Instrument constitutes the **Amended and** Restated Bylaws of the Saint David's Society of Minnesota, Inc., effective August 11, 2024.

#### **Article I: CORPORATE SEAL**

The Corporation shall not have a seal.

#### **Article II: MEMBERS**

<u>Section 2.1</u> The Membership of the Corporations shall consist of one class of Members. Natural persons who pay the annual dues and who support the purpose of the Saint David's Society of Minnesota shall become Members. The annual dues shall be fixed at a meeting of the membership by a majority vote, upon the recommendation of the Board of Directors.

<u>Section 2.2</u> Membership shall terminate at the end of one year, pending renewal. A Member shall not be expelled or suspended, and a Membership may not be terminated or suspended before the end of the stated term, other than for nonpayment of dues or fees, except when a Member is given:

- not less than fifteen (15) days' prior written notice of the expulsion, suspension, or terminations, and the reasons for it, and
- an opportunity to be heard, orally or in writing, not less than five (5) days before the effective date of expulsion, suspension or termination by a person authorized to decide that the proposed expulsion, termination, or suspension not take place.

<u>Section 2.3.1</u> A regular meeting of voting Members shall be held annually at such day and time as the Board of Directors shall determine.

<u>Section 2.3.2</u> Unless otherwise required by law or the Articles or Bylaws of this Corporation, notice of all Member meetings must be given notice at least fifteen (15) and not more than sixty (60) days before the meeting. The notice must contain the date, time and place of the meeting, and an agenda, including any nominations for Directors and Officers and any proposed changes in the Articles of Incorporation or Bylaws.

Section 2.3.3 If a regular meeting of voting Members has not been held during the proceeding fifteen (15) months, at least twenty-five (25) Members with voting rights or ten percent (10%) of the Members with voting rights, whichever is less, may demand a regular meeting of the Members by written notice of demand given to the President or the Treasurer of the Corporation. Within thirty (30) days after receipt of the demand, the Board shall call a regular meeting of Members to be held on notice no later than ninety (90) days after receipt of the demand at the expense of the Corporation. If the Board does not call a meeting within thirty (30) days after receipt of the demand, those Members making the demand may call a meeting.

<u>Section 2.4</u> Unless otherwise provided by law, by the Articles of Incorporation or by these Bylaws, a quorum for a meeting of Members shall consist of those Members in good standing who attend a duly called meeting of the Members and are entitled to vote at the meeting. If a person holding a family membership is present at the meeting, that person's family membership shall be counted as two members being present for purposes of a quorum.

<u>Section 2.5</u> Except where a larger portion or number is required by law, by the Articles of Incorporation or by these Bylaws, the Members may take action by the affirmative vote of a majority of the Members present at a duly held meeting.

Section 2.6 All individual Members over the age of 16 shall be entitled to one vote on any matter properly presented to the Members. Family Memberships shall be entitled to two votes on any matter properly presented to the Members, but each family member vote must be made personally. Voting by proxy shall not be permitted, but absentee voting shall be allowed so long as ballots submitted in writing are retained in the written records of the Society for the time period required by the Minnesota Nonprofit Corporation Statute. Voting shall be permitted at a meeting, including at a meeting held via any form of electronic communications allowed by the Minnesota Nonprofit Corporation Statute. Absentee votes may be submitted via U.S. first class mail, or via any form of electronic communications allowed by the Minnesota Nonprofit Corporation Statute. When Society members are not present at meetings at which matters to be voted on by the membership are presented, and were provided written notice of the vote and specific matters to be voted upon voted upon, all unreturned ballots shall be counted as ballots in favor of the matter voted upon.

#### **Article III: BOARD OF DIRECTORS**

<u>Section 3.1</u> The business and affairs of the corporation shall be managed by or under the direction of a Board of Directors of not less than **three (3)** nor more than **seven (7)** natural persons elected by the Members. All Officers shall be Directors; all other persons elected as Directors shall be Directors at large. Each Director must be a member in good standing.

Section 3.2 Directors at large shall serve for a term of three (3) years and shall be so elected that approximately one-third (1/3) of the Directors at large shall be elected each year.

<u>Section 3.3</u> At all meetings of the Board of Directors, a majority of the Directors then in office shall be necessary and sufficient to constitute a quorum for the transaction of business, but if less than a quorum of Directors is present at

a meeting, they may not vote on official Board business, but a majority of the Directors present may adjourn the meeting without further notice.

<u>Section 3.4</u> Except where otherwise required by law, the Articles of Incorporation or these Bylaws, the affirmative vote of a majority of the Directors present at a duly held meeting shall be sufficient for any action.

<u>Section 3.5</u> Any action, other than an action requiring membership approval, may be taken by written action signed by the number of Directors that would be required to take the same action at a meeting of the Board of Directors at which all Directors were present provided that all Directors shall be notified immediately of the effective date, except that failure to provide such notice does not invalidate the written action.

<u>Section 3.6</u> The Board of Directors shall have regular meetings at least four times per year at such places and times as it shall establish by resolution. **Meetings may be held via any form of electronic communications allowed by the Minnesota Nonprofit Corporation Statute.** 

Meetings of the Board of Directors shall be open to all members of the Corporation, except that the Board of Directors may, in their discretion, meet in executive session. Only members of the Board of Directors shall vote at meetings of the Board. The minutes of the meetings of the Board of Directors shall be open to all members of the Corporation. Notice of any meeting of the Board of Directors must be given at least five (5) days prior to the meeting. Notice may be given by mail, fax, or electronic communication.

<u>Section 3.7</u> A Director may resign at any time by giving written notice of their resignation to the Corporation at its registered office. The resignation is effective when received by the corporation unless a later date has been specified in the notice.

<u>Section 3.8</u> A Director may be removed from office by the affirmative vote of a majority of the Directors present at a duly held meeting; provided that not less than five (5) nor more than thirty (30) business days' notice of such meeting stating that removal of such Director is to be on the agenda for such meeting shall be given to each Director.

<u>Section 3.9</u> In the event of death, removal or resignation of a Director, a successor to fill the unexpired term shall be elected by the affirmative vote of a majority of the Directors present at a duly held meeting.

Section 3.10 Special meetings of the Board of Directors may be called at any time upon request of the President or any two (2) Directors, provided that any such request shall specify the purpose or purposes for the meeting. The Directors who call the meeting shall set the date for the special and shall give not less than five (5) nor more than thirty (30) business days written notice of the time, place, and purpose of such special meeting.

<u>Section 3.11</u> A meeting of the Board of Directors may be conducted via any form of electronic communications allowed by the Minnesota Nonprofit Corporation Statute.

#### **Article IV: OFFICERS**

Section 4.1 The Officers of the Corporation shall be President, Vice President, Membership Coordinator, Treasurer, and such other Officers as the Board of Directors may, from time to time, appoint. The Officers shall each serve a three-year term.

<u>Section 4.2</u> The duties of the Officers of this Corporation shall be as outlined in each subsection below:

- President: The President shall coordinate general active management of the business. The President will be expected to preside at all meetings of the Board of Directors and of the members and ensure that minutes are taken at each meeting. They shall also perform such duties as may be required by law and as determined from time to time by actions taken by the Board of Directors during regular or specially called meetings.
- <u>Vice President:</u> The Vice President shall work in cooperation with the President to maintain general active management of the business of the corporation and will perform the duties of the President in the President's absence. The Vice President may also perform such duties as may be determined from time to time by actions taken by the Board of Directors during regular or specially called meetings.
- <u>Membership Coordinator</u>: The Membership coordinator shall maintain and update the membership database; communicate with members about membership renewal, including updates regarding individual and family membership fees; and provide requested lists and updates as needed for conducting Society business and events.
- **Treasurer:** The Treasurer shall have charge of the corporate treasury, receiving and keeping the monies of the Corporation, and disbursing corporate funds as authorized. The Treasurer shall perform such other duties as may be determined from time to time by the Board of Directors or by the President. Specifically, the Treasurer shall: (1) keep accurate financial records of the Corporation; (2) deposit money, drafts, and checks in the name of and to the credit of the Corporation; (3) endorse deposits for notes, checks and drafts received by the Corporation as ordered by the Board; (4) disburse corporate funds and issue checks and drafts in the name of the Corporation, as ordered by the Board; and (5) provide at each meeting of the Board a written account of transactions by the Treasurer and of the financial condition of the Corporation. The Board of Directors may establish an audit committee to review the performance of the Treasurer at any time and shall establish an audit committee to audit the books of the Corporation within thirty (30) days of the date that any new person assumes the duties of Treasurer. The Treasurer shall prepare, or cause to be prepared, the annual Form 990 Information Return and shall send it to the IRS via certified mail, return receipt requested, on or before the due date, if such Information Return is required by Internal Revenue Service regulations.

Section 4.3 All Officers shall be Members of the Board of Directors.

<u>Section 4.4</u> An Officer may resign at any time by giving written notice to the Corporation. The resignation is effective without acceptance when the notice is given to the Corporation at its registered office, unless a later effective date is named in the notice.

<u>Section 4.5</u> Any Officer may be removed, with or without cause, by the affirmative vote of a majority of the Directors present at a duly held meeting of the Board of Directors for which the notice stating such purpose was given.

<u>Section 4.6</u> A vacancy in an office because of death, resignation or removal may be filled by the Board of Directors.

#### **Article V: COMMITTEES**

#### **Section 5.1 Standing Committees**

The Corporation shall appoint such other committees as may from time to time be deemed necessary by resolution of the Board of Directors. These committees may consist of persons who are not also members of the Board and shall act in an advisory capacity to the Board.

#### **Article VI: STANDARD OF CARE**

<u>Section 6.1</u> It is the responsibility of each Officer and Director of this corporation to discharge his or her duties as an Officer or Director in good faith, in a manner the person reasonably believes to be in the best interests of this Corporation, and with the care an ordinarily prudent person in a like position would exercise under similar circumstances.

#### **Article VII: AMENDMENTS**

<u>Section 7.1</u> These By-Laws may be amended at any meeting of the Society by a majority vote, provided the proposed amendment was published with the call for the meeting.

# **PAST EVENTS (January - June 2024)**

#### Pub Gathering & Poetry Reading - January 27, Merlin's Rest Pub (Minneapolis, MN)

About 15 people came together for good food, drink, and poetry. We were all delighted to listen to several poems by Chris Martin, new member, poet, and visiting professor at Carleton College. Chris' Welsh roots are in *Gwytherin*, a small town in north Wales where his family (the Hughes's) lived on a sheep farm called Craig Bach for hundreds of years. His seventh great-grandparents are buried in the graveyard there under a 2,000-year-old yew tree. Chris read poems from a project that is in conversation with the "Legendary Poems" of Taliesin, and a short excerpt of a novel-in-progress that is set in both Minneapolis and *Gwytherin*.

Chris is the author of four award-winning collections of poetry and a recent work of nonfiction, *May Tomorrow Be Awake: On Poetry, Autism, and Our Neurodiverse Future* (HarperOne, 2022). He is also the cofounder of Unrestricted Interest, an organization devoted to neurodivergent listening, languaging, and learning. Chris received a travel grant from the St. David Society Foundation to visit Wales and connect with his roots and a few Welsh poets. We will hear about his adventures in September (*See* Upcoming Events on Page 1). A fine poet to add to our talented membership!

#### St. David's Day Celebration - March 3, Zvago St. Anthony Park (St. Paul, MN)

At our annual celebration of Wales and all things Welsh, we met at the condo of members David and Karen Davies – a beautiful and roomy space. We had a lunch of sandwiches catered by D'Amico's, and then heard from the Rt. Hon. Liz Saville Roberts who joined us by Zoom to talk about what is going on in Wales today and her work as a Plaid Cymru MP (Minister of Parliament). *Plaid Cymru* is the Welsh nationalist political party, committed to Welsh independence from the UK. The event ended with some singing of Welsh songs and, of course, the Welsh national anthem, *Mae Hen Wlad fy Nhadau*.

# Cymanfa Ganu (Welsh Hymn Sing) & Cawl Cennin (Not a Society Event) – March 10, St. Anthony Park Lutheran Church (St. Paul, MN).

Long-time member Mary Mergenthal offered and organized this *cymanfa* (a gathering for Welsh hymn singing) with her church members. Longtime Society member Karen Wojahn of Windom, MN directed, and the church's organist, Joshua Lindgren, accompanied about 100 singers in four-part harmony. Immediately after the singing, authentic Welsh tea, Welsh cakes, and Welsh leek soup (*cawl cennin*) were served.

## Well-Read Dragons Book Group - Books Discussed on Zoom:

February 3 & April 6, 2024: The Long Field, by Pamela Petro

**June 1, 2024**: *Whaling,* by Nathan Munday

**From Janice Barbee:** A personal highlight was that on April 6, Pamelo Petro, author of *The Long Field*, joined us for a fascinating conversation. Her book explores the very Welsh notion of "hiraeth." ("It is like the bone-deep longing felt for something, a home, a lover, a language, your younger self - that you left behind."). Even if you missed the discussions, you might want to read this wonderful book!

**From Shannon King:** *Whaling*, by Nathan Munday is an exciting adventure story based on historical fact. It takes place in 1790. Nantucket whalers are invited to found the port of Milford Haven in Wales. We learned what the arrival of these hardy Quakers – immigrants to America a century before – meant for the local people, and the meaning of the beached whale that preceded them. As two cultures rubbed against each other, distrust grew, driven by the local preacher. I really liked Munday's unique writing style, interspersing notes from historical journals with his fictionalized story. If you have not read this book, I highly recommend it.

## My First Cymanfa Ganu Experience

The St. Anthony Park Lutheran Church's Spring *Cymanfa Ganu* was well attended by approximately 100 people. It was great to see so many folks. Organized by Mary Morris Mergenthal, the afternoon began with Cathy Victorsen playing a number of Welsh tunes. A seasoned performer, she has played the harp for more than 30 years, both concert pedal as well as Celtic harps. I was mesmerized watching her play and, because harp solos – not to mention Welsh harp solos – are a rare happening (the harpist is often tucked away near the back of an orchestra or ensemble), it was a special treat to be able to see someone so experienced playing tunes up close.

During the event attendees were seated in the sanctuary, organized by sections based on vocal range. That allowed for a wonderful blend of voices, creating a rich and balanced experience. Karen Wojahn, from Windom MN, directed the singing and Joshua Lindgren, director of Worship and Music at St. Anthony Park Lutheran Church was the organist for the event. Having grown up with many Danish traditions, by attending the Spring *Cymanfa*, I had an opportunity to experience something from my husband's heritage. I can now understand the wonderful memories and sense of camaraderie a *Cymanfa* creates.

# NAFOW 2025 - Twmpath Anyone?!

Do the Welsh names *Ffansi Ffarmwr* or *Pwt-ar-y-Bys* mean anything to you? They happen to be very familiar names within the Welsh dancing world—to dancers and musicians who live to dance, who revel in the magic of Celtic folk tunes combined with the whirling, turning, elegant bowing and curtsying which make up Welsh folk dancing; and to *twmpath* magicians, the people who not only dance or play music at Welsh folk dance sessions (*twmpaths*), they teach and lead others in the art of the dances.

One of those magicians lives in our midst, and her name is Laurel Bradshaw. I met Laurel years ago, back in the late '80s/early '90s, soon after she relocated to the Twin Cities. Laurel joined the St. David's Society and organized our first Welsh folk dance troupe, *Traed y Ddraig* (Feet of the Dragon). Gaining certification as a Welsh folk dance instructor through the Folk Dance Society in Wales, Laurel continued dancing and calling (leading) dances over several years at Welsh Heritage Week. In Minnesota, we soon had a group of dancers (some of whom are still around)! We had so much fun learning, practicing and performing *Ffansi Ffarmwr*, *Pwt-ar-y-Bys*, and many more dances at Celtic Festivals, at the International Festival in St. Paul, at local fairs, retreats and on special occasions.



Though our dancers aged and, in some cases, moved away, and as interest waned, intrepid Laurel has taken to leading folk dance sessions at Welsh Heritage Week, at the Great Plains Heritage Center in Wymore, Nebraska, at the Cornish Gathering in Mineral Point, Wisconsin, and at the North American Festival of Wales (NAFOW). All who participate have a rollicking, fun time, regardless of age and ability. And this is where you come in - you are warmly invited to step into this magical world in Pittsburgh, Pennsylvania where Welsh folk dancing will again be featured.

Laurel will teach some easy Welsh folk dances at one of the hour-long dance sessions. Participants will dance to live music played by a session band organized and led by Danny Proud, who has danced and accompanied dancers at Welsh Heritage Week for two decades.

We gave this workshop at last year's NAFOW in Lincoln, Nebraska and we are excited to be asked to do it again this year. Won't you please join us in the dance? We certainly hope so!

# **Remembering Nancy Powell**

Nancy Lee Powell was born December 10, 1942 in Brooklyn, New York. She was the first child of her parents, Luther and Dorothy Powell. Her father was teaching at Drew Seminary in Patterson, New Jersey, and was out of town as the due date approached. Because there was still plenty of time, Dorothy was surprised to hear Luther's car pull up. He came home early saying that something told him to get home. Nancy came that night, prompting a mad dash into New York City. Nancy arrived at Methodist Hospital in Brooklyn N.Y. Luther and Dorothy hadn't even had time to pick out a name, so Nancy's Birth Certificate reads Baby Powell.

Nancy was the oldest of 5 siblings - Robert, the twins MaryAnn and Douglas, and Jim - 10 years younger. Being a minister's kid, she grew up at Drew Seminary (Patterson, New Jersey), McCormick Seminary (Chicago, Illinois), and Storm Lake, Iowa, where she graduated from high school. She went on to college and graduated from Nebraska Wesleyan in Lincoln, Nebraska. While in college, she was so upset that "girls" were not allowed to play on the men's team though she could beat most of them. She formed her own team.

After graduation, Nancy headed for the University of Minnesota to undertake graduate work in sociology. She took a job with Hennepin County as a social service worker and stayed with them until she took early retirement.

Nancy had many interests and many talents. She loved playing tennis and coached the neighborhood kids. She found her little Mayview farm house in Minnetonka in the middle of a snow storm and she fell in love with the property. Two of her favorite additions to the property were the prairie she put in and watched throughout the year, and a Little Free Library, which she kept stocked with books for the neighborhood kids.

Nancy was an excellent photographer and had a special talent for taking photos of children. She loved to travel – and took wonderful photos as she did so. She put together slide presentations of trips taken to China, Tibet, Portugal, Morocco, Chile, Galapagos, Belize,

Wales, and England.

Nancy's musical talents were expressed by playing the piano and singing. She had an amazing Soprano voice. She sang with the North American Welsh Choir and traveled to Wales, where she sang in some amazing Cathedrals.

Nancy was passionate about her Welsh Heritage, and she had an extensive library covering Wales and all things Welsh. She was a longtime member of the Saint David's Society of Minnesota and she enjoyed attending Gymanfas where she could sing and visit with old friends.

Forever interested and curious, Nancy was often heard to say that she had many other pieces of information to follow up on. Her research was beautifully organized and she kept extensive notes. Somehow she also found time to work with local community organizations and historical societies.

She was a special friend to all who knew her. Kind, generous, and always interested in you and your heritage. She was also a fiery redhead, with a strong sense of justice and fairness, and she tried with all her might to right the wrongs she saw in the world. She was one of a kind.

She is truly missed.

# **Nancy Powell Remembered**

Nancy Powell often appeared quiet and unassuming. But beneath that quiet exterior was an extraordinarily thoughtful, considerate and dedicated person. She was a respected historian who pursued early Protestant church history in the Midwest. Marveen and I met Nancy when she wanted information about Marveen's great-great-grandfather, Reverend John Evans of Lime Springs, Iowa, for her church history research. We and Nancy became better acquainted when she and Vern Drilling joined our St. David's Society Well-Read Dragons book club.

One major accomplishment of Nancy's was the preservation of a beautiful stained glass window with its own rich history that she discovered in a church building in Wayzata that was about to be sold and torn down. The window had originally been in the church building for Plymouth Congregational Church in Minneapolis. When Plymouth Church built its present building in the early 20th Century, Plymouth donated the window to a new church in Wayzata. Nancy thought the window should be saved and given back to Plymouth Church. She knew that Marveen and I were members of Plymouth, so she contacted me and sent me a photo of the window. I passed that information on to Plymouth's Senior Minister, Jim



Gertmenian. Jim learned that the funds for getting that window originally came from the grandfather of Gary Reierson, the head of the Greater Minneapolis Council of Churches. Gary led the fundraising to obtain the window and install it in an addition to Plymouth's church building.

The area in the church where the window is located is the Jones Common Area, named in honor of Vivian Jones. Reverend Jones was originally from Wales and served as the Senior Minister at Plymouth for many years. Marveen and I brought Nancy to the dedication ceremony for the window and I was able to introduce Nancy as the one responsible for Plymouth being able to preserve that part of its rich history.

Nancy's interest in church history led her to join an organization of accomplished historians with expertise in Minnesota's 19th Century history. A friend of mine, who is also a member of that group, Bruce Kohn, wrote a book, *Dakota Child, Governor's* 

Daughter: The Life of Helen Hastings Sibley, about the daughter of Henry Sibley by his Dakota Indian wife. Bruce told me how Nancy was a real inspiration for him when he showed her an early draft of the book. She helped him locate additional research that was very useful. In her own quiet way, Nancy was an inspiration for <u>all</u> who knew her.

On an especially personal note, I'd like to share that when I was president of the St. David's Society, Nancy and Vern Drilling presented me with a t-shirt in honor of my Viking ancestry. It has a bunch of runes, and the words: "If you can read this, then you are Norwegian." Another fond memory is that Nancy once wore a sweatshirt with "Drew University" written on it to a book club meeting. Drew is a university in Madison, New Jersey. I think she said her father taught there, which I found to be a very interesting connection.

When I joined what became the Popham Haik law firm after law school, I was sent to attend a training course for new hires held by one of the of the big accounting firms out east. Where was the course taught? At Drew University. In one month on Drew's beautiful campus surrounded by accountants, I learned enough to be very useful to firm litigators that sued accounting firms for aiding and abetting securities fraud! I told Nancy that I had nothing but good memories from my month at Drew.

And I have nothing but good memories of Nancy.

# My - and Our - Friend, Nancy Powell

There is so much I could say about time spent with Nancy over the years that I knew her, but I will keep this (fairly) short. I first met Nancy on the North American Welsh Choir's first tour of Wales in 2002. Nancy and I did not spend much time together outside of rehearsals and concerts – we were not close in age, I was busy memorizing music and spending time with my father (also a choir member) and my brother (choir videographer), and Nancy and Vern Drilling (also a choir member) had places to go and things to do. I remember that they made the most of their time in Wales!

I again met Nancy at an Annual Picnic, not long after I had joined the St. David's Society. I quickly learned of her love of history and of Welsh history in particular, yet I did not connect the dots about our earlier meeting until I was watching the Wales choir DVD with my father and saw myself standing and singing right next to her! Very slowly, over the course of many conversations, I got to know Nancy better. And the more I got to know her, the more I grew to value the time we were able to spend together.

Nancy was a very independent and private person, and I was this ever-moving ball of wildfire. She was early to bed and early to rise, and I was an intractable night owl. And our friendship worked because Nancy was also very patient, very generous and very kind. It also helped that we both had a sense of humor about ourselves and about life. Our conversations ranged from aspects of Minnesota history to places she had traveled to; from things she was reading to results of her research.

When COVID-19 hit, Nancy was the person who checked on me the most – and I am not surprised because I had the honor of seeing Nancy advocate for Vern when he was being told things by persons charged with his care that demonstrated they had no idea who Vern was and what he was capable of. I had experienced something similar with my father and we bonded while looking for solutions that worked for Vern as well as his caregivers. What I admired most was the way that Nancy refused to let anyone put Vern into a limiting box and how she looked for every opportunity to ensure that Vern was given opportunities to play the piano and engage with life in a way that honored him. I feel certain that the people she advocated for throughout her professional career were equally happy to have Nancy in their corner.

As my legal career picked up, Nancy and I got together less often, but whenever we did meet we made the most of the time available to us. Some of my fondest memories are time spent eating delicious food, talking about our goals and how we were working to meet them, sitting in the sun and looking out at the prairie she created, and walking or just listening to the birds. What I think what I will miss the most, though, is being able to call Nancy and talk about things we were wrestling with in life and being able to talk with her about multifaceted matters of human history in a frank and respectful way. That said, I do hear her voice from time to time and I know she has made a lasting impact on my life that will never fade. And I have yet to drive by a lovely prairie that I don't feel that Nancy is there, enjoying the seasonal exuberance, beauty and stillness that prairies so reliable deliver. So I know she is still with me and that brings me comfort and joy.
